**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF KING COUNTY
FIRE DISTRICT NO. 13 (VASHON ISLAND FIRE & RESCUE) LEVYING THE
2023 PROPERTY TAXES AND APPROVING THE 2023 BUDGET**


BE IT HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF KING COUNTY FIRE DISTRICT NO. 13 (VASHON ISLAND FIRE & RESCUE) AS FOLLOWS:


1. That the County Assessor-Treasurer has notified the Board of Commissioners of Vashon Island Fire & Rescue that the estimated assessed valuation of real property lying within the boundaries of said District for the assessment year of 2022 and tax year 2023 is estimated to be \$5,031,109.098.
2. That the Honorable County Council of King County, Washington be and is hereby requested to make a levy for 2023 for said Vashon Island Fire & Rescue of \$5,674,747, which includes the district's regular levy of \$5,642,350, a refund of \$32,397 from prior years and new construction of \$16,855, plus increases due to the increase of state assessed values.
3. That pursuant to RCW 84.52.125 the fire district hereby protects the district's tax levy from pro-rationing under RCW 84.52.010(2) by imposing up to a total of twenty-five cents per thousand dollars of assessed value of the tax levies authorized under RCW 52.16.160 outside of the five dollars and ninety cents per thousand dollars of assessed valuation limitation established under RCW 84.52.043(2), if those taxes otherwise would be prorated under RCW 84.52.010.
4. That the Treasurer of King County, Washington be and is authorized and directed to deposit and sequester the monies received from the collection of the tax levy specified in section 2 into the following account:
 - a) \$5,574,747 into the District's Expense Fund, Account #10-013-0010




